TERMS OF CONTRACT:

EDTA and/or JPdL reserve the right to determine eligibility of any company, product or service for inclusion as a sponsor. This agreement is subject to all terms and conditions outlined in the lease between the Palais de Congrès des Montréal (hereinafter referred to as "Facility") and EDTA and JPdL. In the event of any inconsistencies, or if the Facility lease addresses issues not covered herein, the terms of the lease agreement will control. The parties agree that Washington, DC shall be deemed the place of the making of this agreement and any suit or other proceeding brought to enforce or construe the agreement shall be brought in the state or federal court with jurisdiction over Washington, DC and no place else. The parties further agree that Washington, DC law will apply in the construction and enforcement of the agreement.

RULES AND REGULATIONS: All sponsors must participate as an exhibitor at the event to be eligible to be a sponsor. Sponsors shall abide by all other provisions of the rules and regulations stated in the official exhibitor services manual, and with fire regulations and all other regulations of governmental agencies and the Facility.
